Director's Report Summary

Julie summarized key items in the Director's Report. She updated the Board on HealthWorks, Social Work Services, Occupational Health Services, Safety Training and Outreach, as well as ROPS and the John May Farm Safety Fund (JMFSF). Budget Update: Julie Sorensen

Let the board know that NYCAMH is actively seeking (2) remote bilingual Ag educator positions. Asking the members to refer anyone they may know that would be interested or with any suggestions on best options to recruit.

Keeping ROPS funding going is looking encouraging at this point. Working on making it part of the farm bill, Julie has a meeting tomorrow. Will update outcome.

JMFSF program Update: NYCAMH requested \$500K from NY State and received \$300K. We are very grateful for the States' support and thank them. However, we do know that amount of funds are on course to be spent out. NYCAMH is looking to for Fundraising ideas to make up the \$200K.

NYCAMH's ideas

- Stone Barn Center collaboration for fundraising dinner. Reaching out to Director to determine any interest on their end.
- Have requested to do Go Fund Me in the past- have been denied by Friend of Bassett,
 FOB. It has been a few years, time to look into this again with FOB
- JMFSF has submitted several application for funds working with FOB

• Suggestions given

- o Virtual Fundraising?
- Dealerships? such as squeeze chute dealers
- o Higher corporate, perhaps going higher than the dealerships would get better results?
- Question of how the FOB funds work- noticed that only JMFSF is listed on the FOB donor webpage.

NYCAMH has several different funds through the FOB. Most are for specific programs, but we do have a NYCAMH Unrestricted fund that we can use at our discretion – It is challenging that only JMFSF is listed on the FOB webpage and can get complicated. Suggestion made to send check directly to NYCAMH and we can make sure it goes toward your intended use. As example-Lisa Ford, Cayuga Milk, generously donated \$ by giving a check directly to Anna Meyerhoff-who then brought it to Pauline- she then forward to

FOB with the NYCAMH unrestricted account number. This can used directly for

our educators.

Cornell Ag Workforce Development/NYCAMH Position Update

Proposal request for \$150K was submitted to the State, for a shared position between NYCAMH and CAWD. We did receive half- \$75K. Regrouped and are now calling this a NYCAMH/CAWD Project. Moving forward with goal of starting late summer or early fall on developing on-line trainings with a focus of on-boarding for employees and management.
